

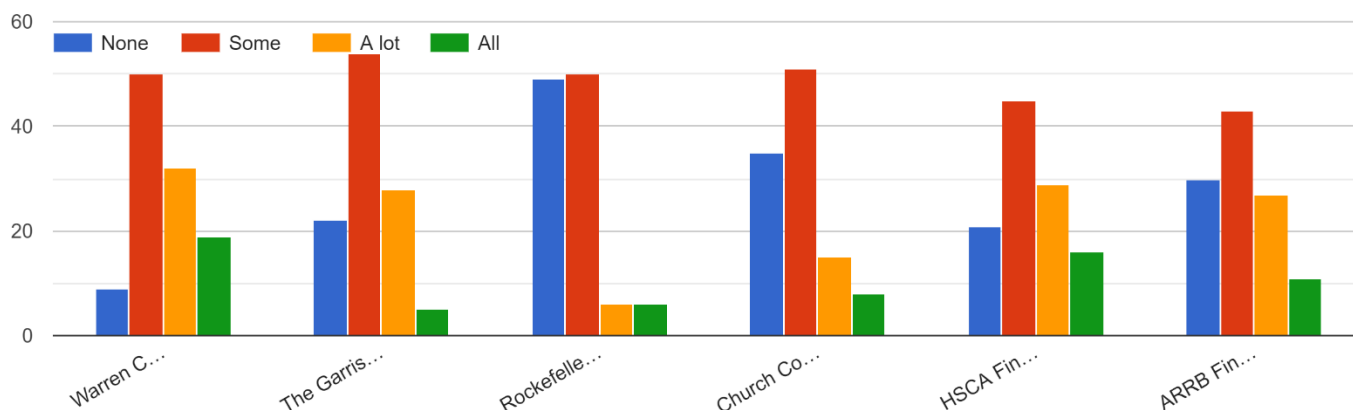
Meek, Boylan and Bleau JFK Assassination Research Project- Report on How the Plot was carried out/Strategies and tactics Survey- April 7, 2024

The survey was sent to 621 potential respondents by email and was closed on April 7, 2024, after one week. Approximately 10 messages came back of non-availability of the recipient. 112 responded to the survey representing 18.4 percent of the population targeted, which even if lower than the first two surveys is excellent. Reports on all three surveys are archived at jfkchokeholds.com and can be found in the media section.

Subject one

This section once again establishes the high level of interest of the survey respondents for the case by their familiarity with documentation around the governmental investigations in the assassination which represents quite a contrast with writers of U.S. history books as per a study conducted by one of the researchers. The Rockefeller Commission report stands out as by far the one that is completely ignored by the respondents. The Warren Commission and the HSCA are the most heavily consulted (*A lot and All*).

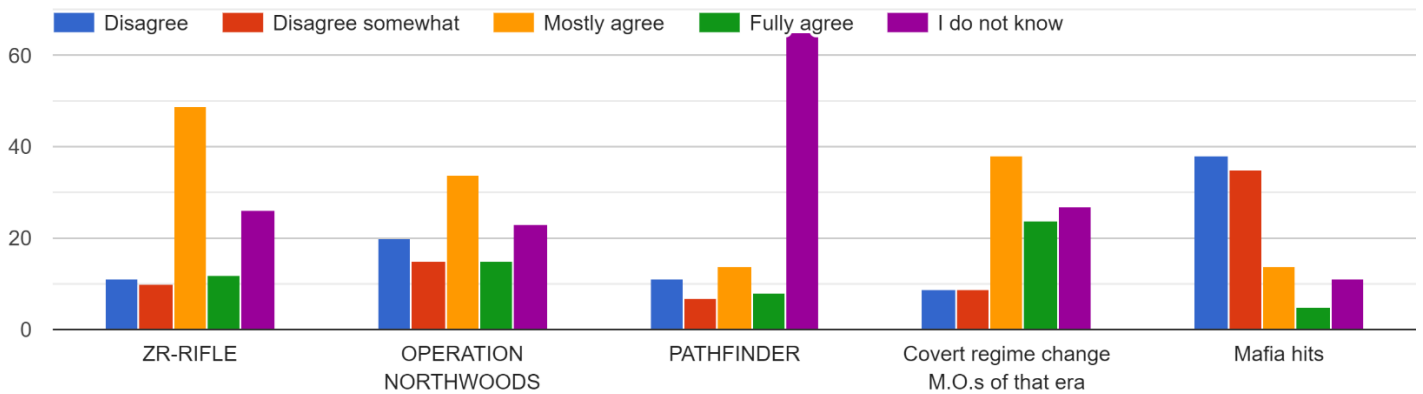
How much of the following have you read?

Compared to previous surveys, there is a larger proportion of *I do not know* responses and relatively fewer Fully agrees or disagrees. Respondents see Northwoods, ZR/RIFLE and a Covert Regime Change operation as what is most likely, a Mafia Hit as least likely and the Pathfinder Operation is not well known.

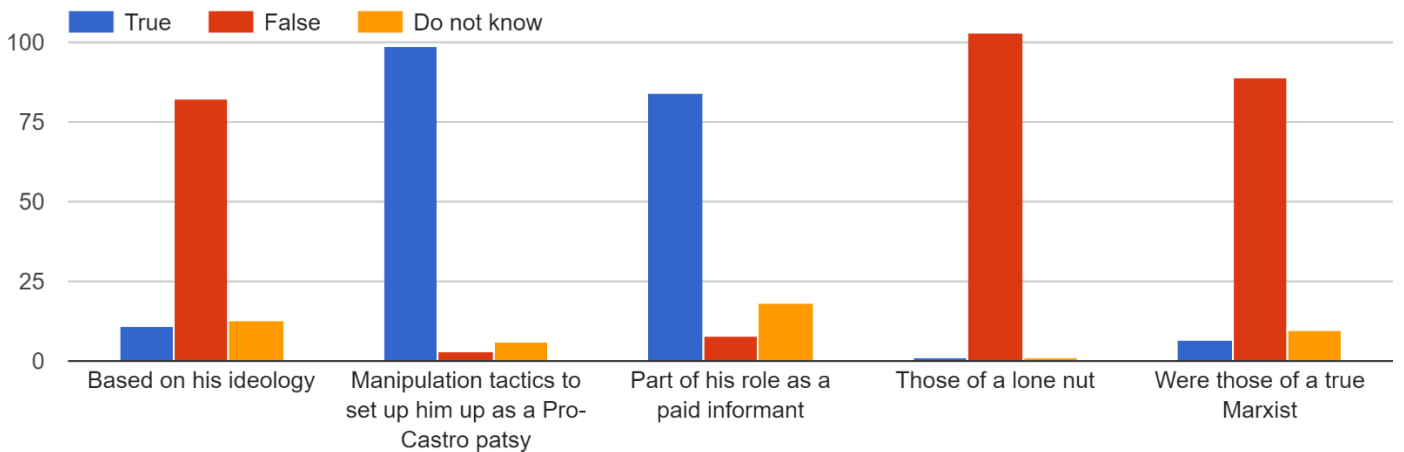

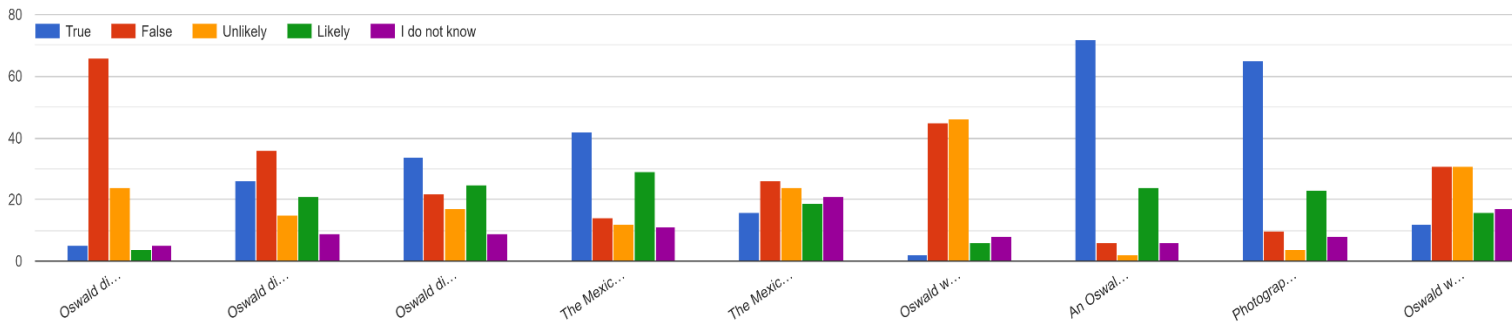
The key here is that almost all respondents are certain Oswald was impersonated in Mexico City and that the evidence of this was kept hidden from the Warren Commission. There is a lot of doubt that Oswald even went to Mexico City. Oswald’s intent to go to Cuba and/or is met with some skepticism.

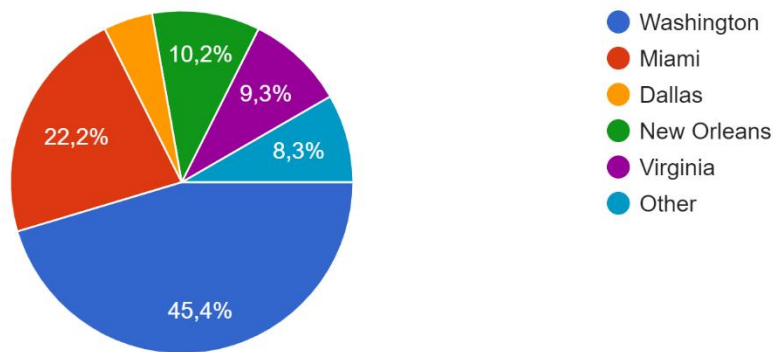
Oswald's alleged travel to Mexico City in September 1963

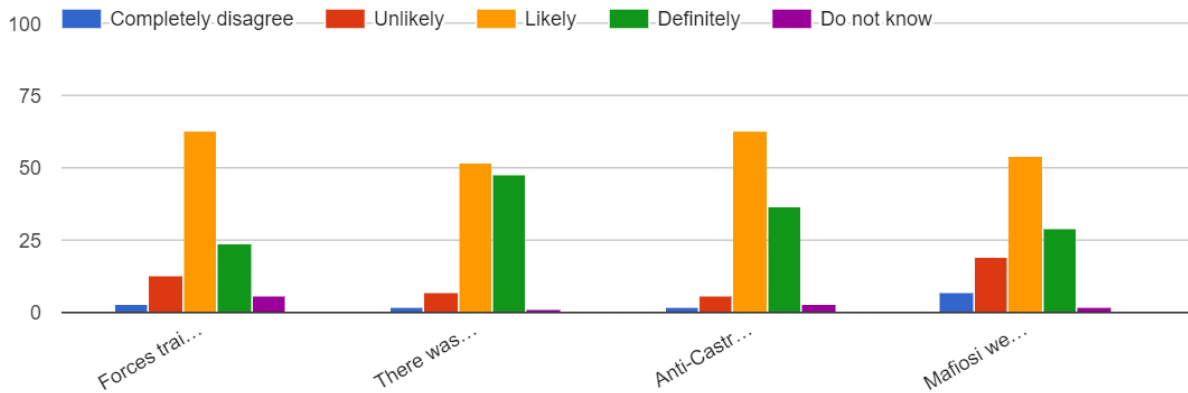
Section Six

The reader is encouraged to read all the answers which speak for themselves. Here are a few highlights: Respondents see a multi-faction force involving members of intelligence forces, mafiosi, soldiers of fortune, anti-Castro Cuban exiles, secret service etc. as being involved. Oswald being removed from the security index, his employment at the TSBD, weakening of security in Dallas, Umbrella man behavior, secret service agent impersonators, the motorcade route and presidential limousine driver are all believed or seen as suspect. Oswald being framed is another common belief.

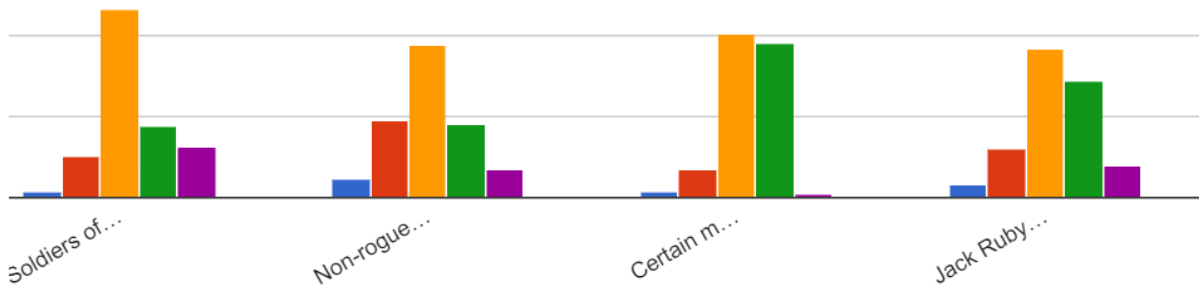
Note: Refer to legend on top for all next charts, each line represents 25 respondents, questions preceding each four charts are presented in chronological order to synch with following diagrams.

- 4) Mafiosi were involved

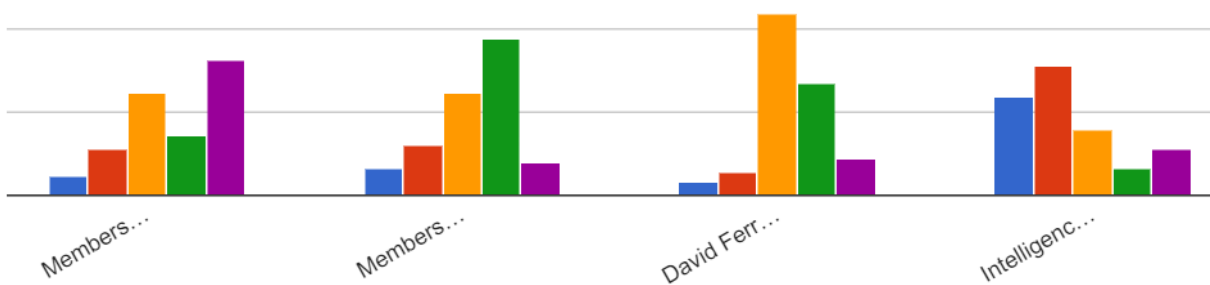

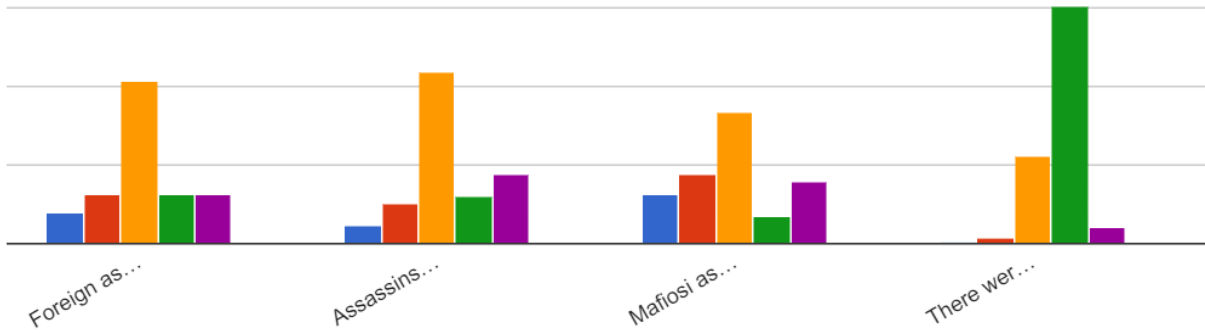
- 5) Soldiers of fortune were involved

- 8) Jack Ruby was recruited by Mafiosi involved in the plot



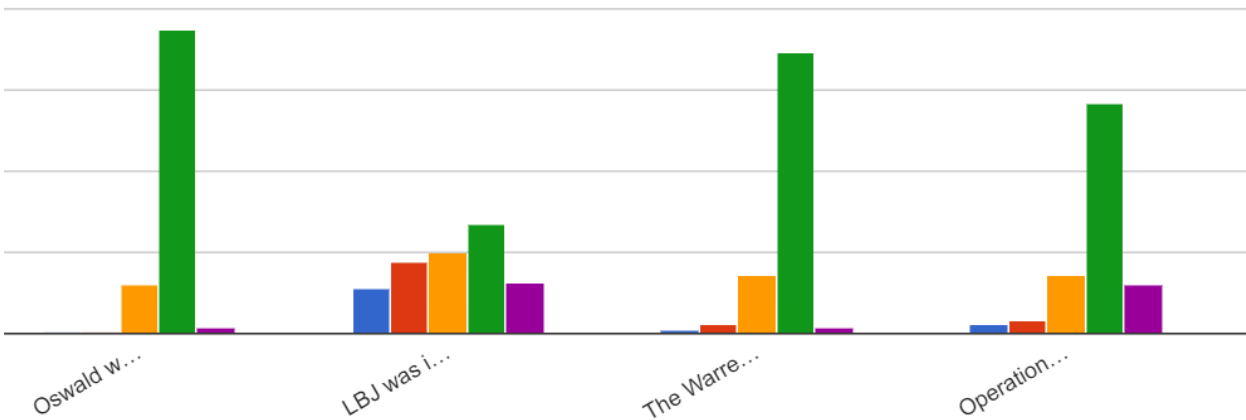
- 9) Members of the 488th Military Intelligence Detachment were involved

- 12) Intelligence forces from foreign countries were involved



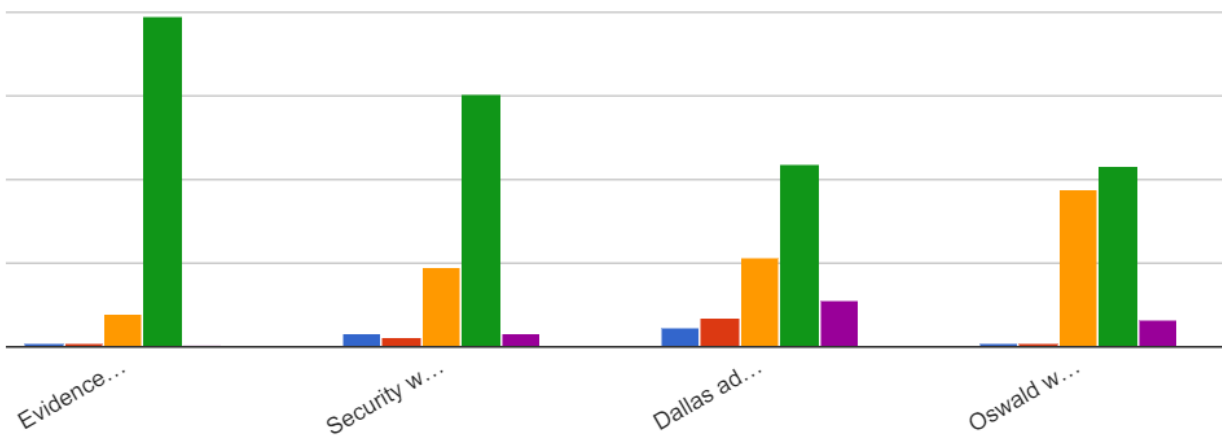
- 13) Foreign assassins were recruited

- 16) There were multiple shooting teams in place



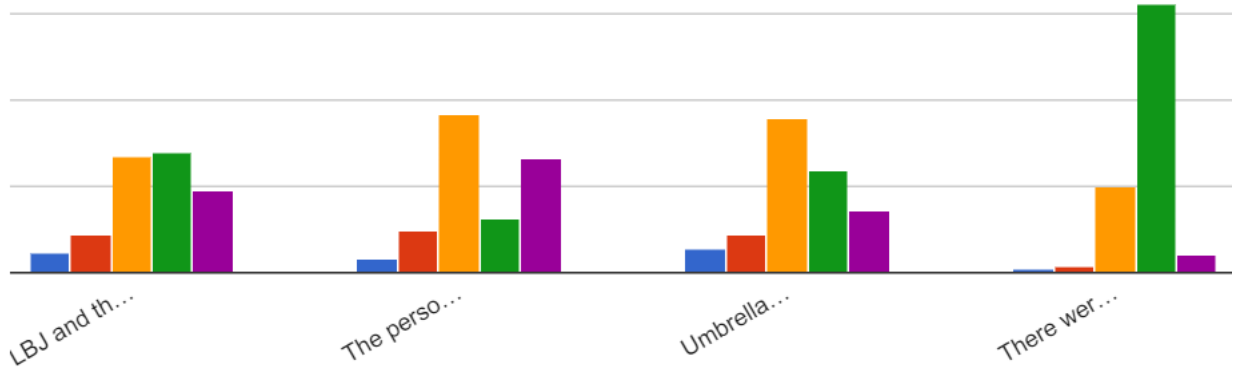
- 17) Oswald was assassinated so that he would not talk

- 20) Operation Mockingbird was used to control the press



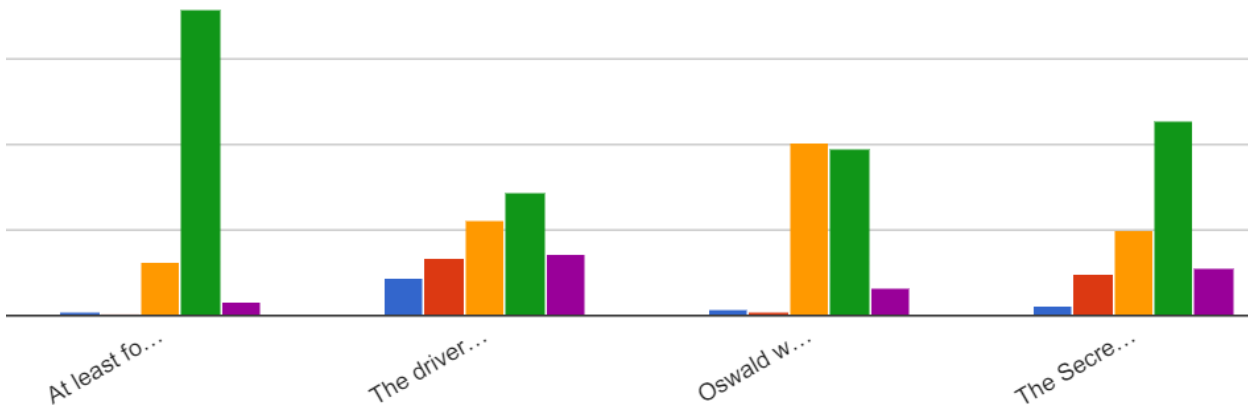
- 21) Evidence was destroyed, hidden and or manipulated to hide the conspiracy

- 24) Oswald was supposed to be killed before being arrested



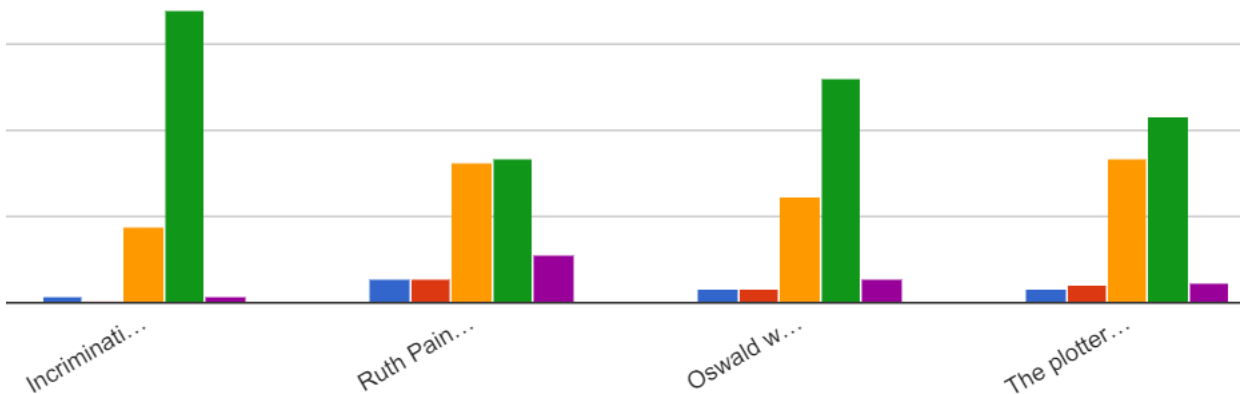
- 25) LBJ and the FBI dictated that there be a lone nut scenario which caught the plotters off guard

- 32) The Secret Service violently removed JFK's corpse from Parkland Hospital to ensure a rigged military autopsy

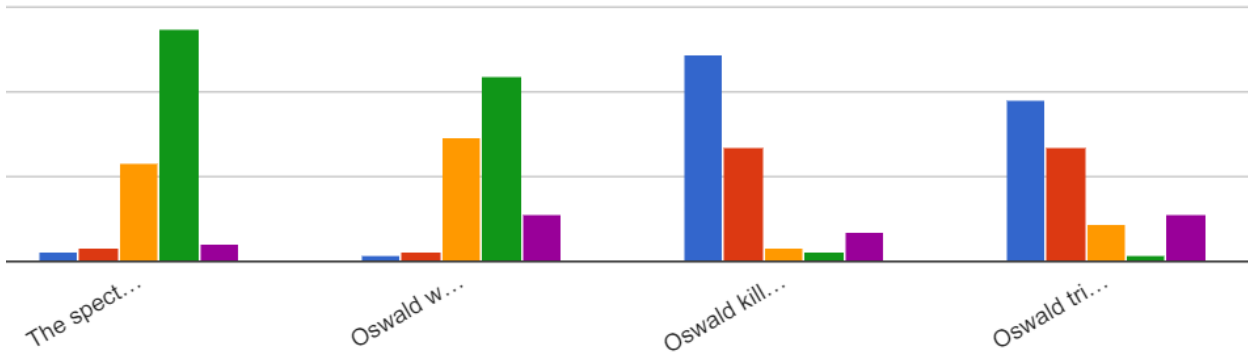


- 33) Incriminating evidence against Oswald was fabricated and/or planted

- 36) The plotters knew that Oswald's links with intelligence would stifle any ensuing investigation

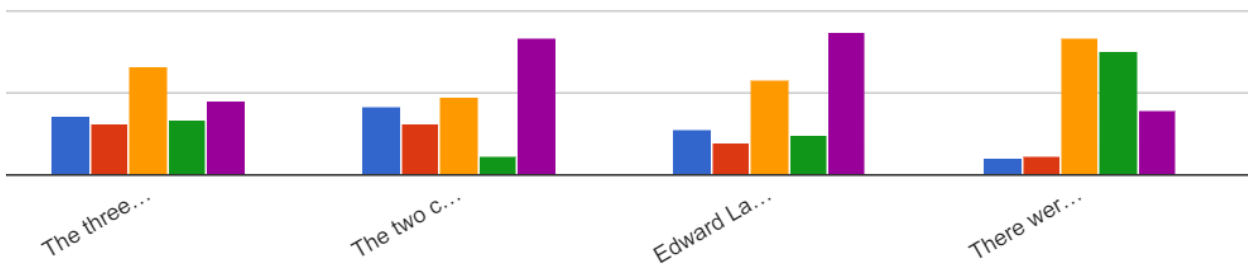


- 37) The specter of nuclear war was used to push the lone nut scenario and was not heartfelt

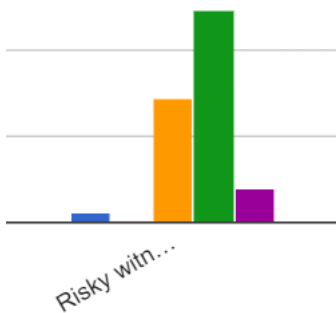
- 38) Oswald was deliberately removed from Intel watch lists shortly before the assassination so that he would not be removed from the motorcade route

I would like to see more about Oswald and his lack of money. If he was being compensated by the FBI or other agencies why was he so poor? He also seemed to have an interest in Marxism at a young age. Perhaps you will delve into the composition of the Warren Commission, the Sprague/Gliskey switcheroo on the HSCA, the stacking of the '68 forensic review, the sabotage of Garrison, the friction Doug Horne found on the ARRB—in short, institutional inertia indicating a whole-of-state rather than a rogue operation.

Excellent probing. Medical coverup and other manipulation of evidence, especially photographic should be an area where the community can come to greater consensus.

The 6th floor has always fascinated me. There were 5 -6 TSBD employees up there that week helping the Floor laying crew from an outside company (who were they?) put plywood over the floor. Except for lunch/break/after hours, the 6th floor seems never to have been empty of people. There is no tactic/strategy question here; just something I wanted to comment on. Umbrella man and Radio man: have they ever been ID'd? I realize a man

claimed to be umbrella man to the HSCA but I don't believe him. The three tramps: have there ever been attempts to computer photo match them with possible individuals

I grew up in Dallas and was 4 at the time of the Assassination and I have original copies of Dallas Morning News and some Dallas Times Herald. The Motorcade route in the DMN on November 22 had the route going straight on Main not turning on to Houston and then Elm...so the Secret Service definitely changed the route.

Multiple patsies (like Jack Lawrence or Gilberto Lopez) for the frontal Knoll shots since the initial kill zone (on turn from Elm) was missed by shooters...WHAT WAS ORIGINALLY PLANNED AND WHAT WENT WRONG! And how this lead to all the film alterations, etc.

Possibly is a useful answer option in many cases. It is hard filling some of this out. Despite following the case for 35 years, there's so much I don't know for sure. It was probably simpler than we think with a "post-action" clean up operation.

How do we define and effect justice for JFK and the untold millions collaterally damaged by his killers?

So tough to say, the questions try not to be loaded but with this topic - it's hard not to be. Maybe just further drilling into the questions that have already been posed? Thank you guys for putting this together.

Hone in on LBJ's role because he was the Mastermind and the Kennedys knew it.

Better questions this time. Still need to separate questions such as assuming Oswald was impersonated in a photo and on audiotape, those are two different questions. I would ask whether Oswald's file was used in a mole hunt; whether other cities were considered as a staging area such as Chicago, Tampa and Miami; whether the autopsy was deliberately sabotaged - I think that is the strongest link to military involvement in both the set up and the cover-up
